Th	ne following regulations sl	nall apply to tempo	rary off premise advertising sig	gns and event signs:					
1.	Spacing of temporar	Spacing of temporary off premise advertising signs and event signs shall be no closer than 30 feet apart with a maximum of four (4) signs posted in 1320 feet (1/4 mile).							
2.	Such signs shall be displayed for no more than seven (7) consecutive days. All companies, corporations, individuals, organizations (public or private) (profit and non-profit) shall not display any temporary off premise advertising signs or event signs sooner than seven (7) days between applications.								
3.	There shall be a permit fee paid of \$25.00. This amount may be changed from time to time; by resolution; at the discretion of the Hazle Township Supervisors.								
4.	Failure to remove any temporary off premise advertising sign or event sign by the conclusion of seven (7) day permit period; unless extended by the Hazle Township Super visors; or any signs found not to have a municipal permit shall be subject to a per diem fine of ten (\$10.00) dollars per sign and be responsible for all costs and charges for prosecution from the District Magistrate.								
5.	The advertising panel of a temporary off premise advertising sign shall not exceed six (6) square feet per side. A banner sign which is attached to a building may be up to 100 square feet. There will be no more than one (1) banner sign allowed per advertising event.								
6.	6. An Event Sign shall not exceed thirty-two (32) square feet in area, having dimensions of 4'x 8'. Such signs shall not be attached to any tree, utility pole or structure within a public right-of-way.
