She's not sure why they put in highway dividers in next to her property and they did all of this without a permit or planning approval. She has a letter from Schumacher Engineering who went there checking on the stormwater complaint and Schumacher said it was not done properly so Tammy said in her eyes it is not a civil matter, it needs to be done properly and the Supervisors should have to do this based on that Schumacher letter. It is not on her and really it is not on Dave. She told Chuck about it and she3 showed him a video and he told her that the engineer is on vacation and he will come and check it out when he is back. Joe said he will go and look at it

and report back to the Supervisors and Chuck will see if any rules or laws were broken regarding the permit issues, etc. and see if there are any violations that can be acted on. Tammy said she will take this to the Court of Common Pleas and sue the township because this is not civil...it is criminal.

Richard Wienches, 119 Forest Hills, thanked the Supervisors for the island work at the park with the stone, it looks fantastic. He also said he is so happy about the bike path on Airport Road. He asked if we can do a parking lot for the fishermen. The Supervisors said the plan is started but that will be a 2026 project.

Mary Jane Starzyk, 1802 West 22nd St., she said she came because of the baseball field at the Hazleton High School. It is open to people from the travel team to use the field but it is only suppose to be on weekends but they are there every day. They are not following the rules in the letter from Nina and the decision of the Hazle Township Zoning Hearing Board.

A woman who resides in Sugarloaf came regarding an energy company that is looking to do a new facility at 42 Tomhicken Road in Sugarloaf...it abuts Hazle Township. They applied to the state for a permit but not to Sugarloaf Township yet. They applied for a height variance. They're currently in Ohio and they do not have a good track record...the plastics they will be dealing with will be coming in from out of the area and it will cause a lot of emissions, etc. Butler Township passed a resolution opposing it and she is hoping that Hazle Township would consider doing that as well.

Elaine Motel, 380 E. 14th St., said they did some work in the back of her place (13th St.) and a lot of the dirt and rocks went down onto her property. She went up to talk to the workers and there is damage to her wall. They did a beautiful job with the curbing but they should have put it next door to her because the water runs down from and through neighbors driveway onto her property and in the winter it freezes. Supervisor Montone said he will have the roadmaster come and check it out tomorrow and said she should show him where she is talking about.

Mercita Deitrich, 1199 SR 940, thanked the Supervisors for the millings in back of her house. She said the drains behind her house and Jan's get absolutely no water (Ski Court). She said when they put them in the pipe is not straight and it goes on a grade, they manholes are not deep enough. She said to come look at our lawns, they are washing away and they just had the first day in months that it was dry and they can cut their grass. She said her soil is washing away and 2-3 inches of rain runs down her sidewalk. The Supervisors told Joe Calabrese to check this out and the elevation of the pipe and advise the Supervisors. She also said that a project went on 2 houses over from them and they are harassing them. The people lied on the permit and said they were building a carport. The Supervisors said that Chuck saw this and told them they have to come before zoning.

Ashley Bahrt, Hazleton, 2 blocks from the Township line. She asked if she could speak about the data center project even though she does not reside in the Township. She stated there was a 5 hour hearing today with Senator Argall at Valley View School, and someone was saying how many jobs and the great economic development it will bring...she said they actually only employ about 30 people and that Senator Argall said that 80-90% of the buildings are not being occupied. She said Hazle Township should gather as much info as possible before we accept it because it will change everyone's lives and future generations as well.

The Italian Festival was fantastic, the people, the food, the fireworks display was unbelievable and the weather was perfect. He said he is a retired disabled combat veteran and he rides an E-bike and he was at the park on Friday (he goes everyday and eats his lunch by the tank) and Jim Montone stopped in the park and told him to take his bike out of the park. Mr. Wienches said he never causes any problem in the park with his bike. He said Jim is a disgrace and lowers the reputation of the other 2 supervisors. Chairman Griguoli said it was done for safety reasons. Mr. Wienches said he pedals and doesn't use electric motor. Jim told him it was a safety issue and he wants to know why it's a safety issue. Joe Galada said he rides bike all over the park and why should Rich be able to do everything in the park that others cannot.

Regina Shovlin, 415 E. 14th St. asked if the Supervisors are doing her curbing or not. She just wants the curb paved and wants to know why they did it up the street. The supervisors are going to take a look at it.

Angelo Christino, Harwood Road, said he has water coming down past his driveway and it was real bad with that big rain storm. There is no sewer outlet on the end of his property. Joe from RJD said the pipe was blocked. The road is very flat and it needs to be milled out and put on slope and an inlet and piping. Supervisors said they will have the drainage issue looked into. Mr. Christino also complained about all the tractor trailers using Harwood Road and he thought there was a weight limit on it. The trucks should be going up to the light at 924.

Dave Scheagan & Kerry Fisher – They came to address the Supervisors about the Cranberry Road water issues in their yards. Kerry said Nicky Pane was there and we was very condescending and he said they would have a chance to talk at the meeting with PennDOT and they weren't given a chance. Up at 924 Landscaping it was a vacant lot and vegetation and trees were there, the water stayed and soaked in. When 924 Landscaping he came in and rearranged everything. Mr. Scheagan said there is a real problem there and it needs to be corrected. The

Supervisors agree and they will get Chuck on this. Gloria Stock also complained about rocks coming down the embankment from 924 Landscaping.

Ashley Bahrt, Hazleton, asked if the Supervisors are aware of the number of buildings in planning phase in Hazle Township now. Supervisor Montone said a lot, around 40 to 50 buildings in planning phase now. Ashley said those buildings are very close to these peoples homes that were just complaining about having water issues and at what point is it causing more issues than it's helping. Supervisor Montone said that the proposed buildings are not being built near these people.
