Temporary Off Premise Advertising signs shall be allowed in B-1, B-2, I-1, I-2, M-1, M-2, BP, and C-1 zoning districts.

The following regulations shall apply to temporary off premise advertising signs and event signs:

1. Spacing of temporary off premise advertising signs and event signs shall be no closer than 30 feet apart with a maximum of four (4) signs posted in 1320 feet (1/4 mile).
2. Such signs shall be displayed for no more than seven (7) consecutive days. All companies, corporations, individuals, organizations (public or private) (profit and non-profit) shall not display any temporary off premise advertising signs or event signs sooner than seven (7) days between applications.
3. There shall be a permit fee paid of \$25.00. This amount may be changed from time to time; by resolution; at the discretion of the Hazle Township Supervisors.
4. Failure to remove any temporary off premise advertising sign or event sign by the conclusion of seven (7) day permit period; unless extended by the Hazle Township Supervisors; or any signs found not to have a municipal permit shall be subject to a per diem fine of ten (\$10.00) dollars per sign and be responsible for all costs and charges for prosecution from the District Magistrate.
5. The advertising panel of a temporary off premise advertising sign shall not exceed six (6) square feet per side. A banner sign which is attached to a building may be up to 100 square feet. There will be no more than one (1) banner sign allowed per advertising event.
6. An Event Sign shall not exceed thirty-two (32) square feet in area, having dimensions of 4'x 8'. Such signs shall not be attached to any tree, utility pole or structure within a public right-of-way.
